Coils manufactured by Farley's, Inc. for installation in machinery manufactured by Farley's, Inc. and sold as replacement coils are warranted by the manufacturer to be free from defects in materials and workmanship under normal intended use and service upon the

This warranty is limited to repairing or replacing the defective coil for five years from the date of purchase if the coil is contained within a new machine manufactured by Farley's, Inc., or five years from the date of installation if the coil is sold as a replacement, upon the following prorated schedule:

- Full Replacement or Repair during the first two years
- Replacement or Repair with customer bearing 40% of cost during the third year
- ලලලම Replacement or Repair with customer bearing 60% of cost during the fourth year
- Replacement or Repair with customer bearing 80% of cost during the fifth year

Manufacturer reserves the right to make the final determination whether to replace or repair the defective coil when received postage or freight prepaid and verified defective by the manufacturer. This Limited Warranty shall not apply to repair/replacements other than those performed by the manufacturer except where prior written approval from Farley's, Inc. is obtained
